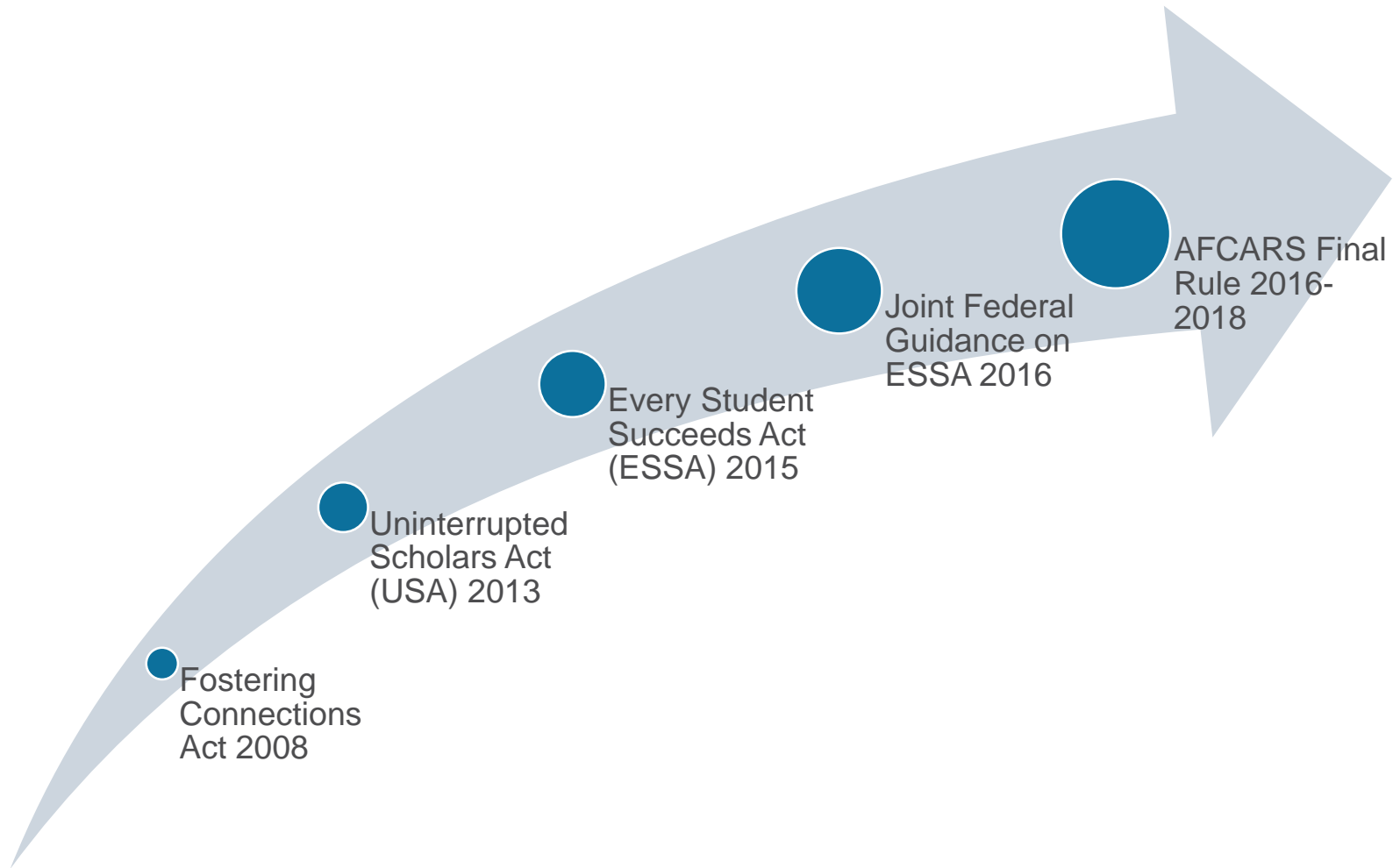
ABA Center on Children and the Law

ESEA Foster Care Provisions

- **School stability protections**
 - Presumption to stay in school of origin / Best interest decision - 20 U.S.C. § 1111(g)(1)(E)(i)
 - Immediate enrollment - 20 U.S.C. § 1111(g)(1)(E)(ii-iii)
 - Transportation - 20 U.S.C. § 1112(c)(5)(B)
- **Points of contact** 20 U.S.C. §1111(g)(1)(E)(iv) / 20 U.S.C. § 1112(c)(5)(A)
- **Removal of “awaiting foster care placement”** 42 U.S.C. 11434a(2)(B)(i)
- **Required disaggregate data collection and reporting** 20 U.S.C. § 1111(h)(1)(C)(ii-iii)

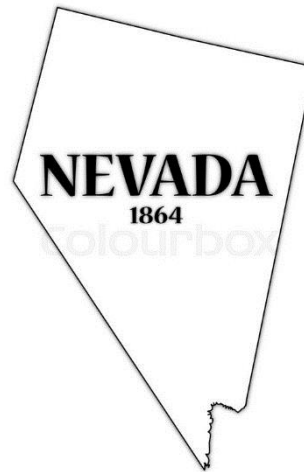

Discussion on Identified Needs: Facilitation Format

1. Invite thought partner states to share 1-2 minutes about their salient strategies for collaboration.
2. Facilitators to identify themes from poll responses of state participants and select one to begin with.
3. States that identified that theme to share 1-2 minute description of their challenge/success or question.
4. Thought partner states to share their thoughts/ideas on the challenge or question.
5. Peers and facilitators to share feedback, probe with additional questions, and offer peer feedback or guidance.
6. Process to repeat for as many identified challenges as time permits.
